VRECC Serves All Valencia County

The new Valencia Regional Emergency Communication Center (VRECC) building in Los Lunas, home to Valencia County's 911 services, is now operational.

The \$3.2 million, 11,490 square foot VRECC building has 13 work stations, with the capability of increasing to at least 18.

Operators handle emergency calls from all across the county, dispatching police, emergency medical services, and fire equipment with firefighters.

In 2017, VRECC operators handled 2,655 calls for people in the City of Rio Communities -- 208, January 2017; 256, February; 279, March; 208, April; 227, May; 228, June; 236, July; 242, August; 199, September; 176, October; 200, November; and 196, December.

The new building is created with the continued growth of the area in mind as well as changes in technology.

The facility was constructed to serve all of Valencia County's residents for several years.

The City of Rio Communities is represented on the

## Do Not Encroach on Pipelines on Property

If you own property in Rio Communities, that property may have a pipeline running through it.

If there is a pipeline, then property owners must realize that any encroachment on a pipeline right-of-way has the potential to create hazardous situations and/or impede a pipeline operators' ability to maintain that pipeline.

Third party coordination with the pipeline operator significantly minimizes the chance of third-party damage and allows for the performance of routine maintenance as well as required state and federal inspections.

In order to perform these critical activities, pipeline maintenance personnel must be able to access the pipeline right-of-way as provided by the easement agreement.

To ensure access, the area on either side of the pipeline in the right-of-way must be maintained clear of trees, shrubs, buildings, structures or any other encroachments

that interfere with the operator's access to the pipeline.

This is the responsibility of the land owner.

Landowners must contact a pipeline's operator for review and approval of any potential encroachments on the right-of-way to ensure the safety of the landowner, the public, and pipeline employees.

## PNM's Fourth Solar Center in the City

PNM now has four solar centers in Valencia County including one in the City of Rio Communities.

The 10-megawatt solar energy center came online at the end of 2015 after PNM invested about \$20 million to build the center in Rio Communities.

The center has 40,250 panels that generate the equivalent of the energy used by 4,025 average residential customers.

The City of Rio Communities has 2,137 households.

The new solar energy center will provide an estimated \$189,000 annually in new tax revenue for Valencia County with some of that going to the City of Rio Communities.

## Addresses on Homes Are Very Important

Rio Communities residents should be sure the address for their home is plainly visible and is correct.

This is important for everyone's safety. A correct address helps ensure emergency personnel can locate a structure when there is an emergency.

All buildings should have approved address numbers, building numbers or approved building identification placed where it is plainly legible and visible from the street or road fronting the property.

Numbers shall contrast with the background and be a minimum of four-inches high with a minimum stroke width of 1/2 inch.

Where access is by means of private road and the building address cannot be viewed from the public right-of-way, then a monument, pole or other sign should identify the building.

If your address does not seem to fit with your neighborhood then check with City Hall.

## **Cleanup Days for 2018**

To help keep Rio Communities clean, the city will have a dumpster in the parking lot of City Hall, 360 Rio Communities Blvd., on one Saturday each month which is generally in the middle of the month.

Those Saturdays are April 28, May 19, June 16, July 21, August 18, Sept. 15, Oct. 20, Nov. 17 and Dec. 15.

Construction of the center on its approximately 103-acre site created 243 local temporary jobs.

The solar center features solar photovoltaic panels mounted on single-axis tracking

devices that follow the sun for increased energy output.

The panels are ten-feet high at their maximum angle.

Solar panels create no air emissions or waste products and do not use water to produce electricity.

The panels can be recycled at the end of their useful life.

#### **Municipal Complex Improvements**

The City of Rio Communities Municipal Complex will be renovated with the front facing Highway 47 undergoing a transformation using a stucco-stone veneer.

The picture on page one shows the proposed renovation of the side facing Highway 47.

The Rio Communities Municipal Complex is part of a set of buildings constructed in 1973 when the area was just starting to be populated.

The City Council hired FBT Architects to coordinate the municipal complex renovations plus other improvements in the City of Rio Communities.

FBT Architects was founded in 1973. The company's employees work on projects using "innovative design combined with unparalleled service."

Funding for many of the Rio Communities improvements comes from state capital outlay funds.

More about those improvements as the projects are being worked on.

### City Officials Sworn In

City of Rio Communities Mayor Mark Gwinn has been sworn in for another four-year term after his re-election in March.

Also sworn in were City Councilors Bill Brown and Joshua Ramsell.

Brown was serving a two-year council term he had been elected to in 2016 and will now serve a four-year term.

Ramsell was elected to a four-year term in March.

In addition, Municipal Judge Heather Benavidez was re-elected and sworn in to office for a four-year term.
