850 Medical Calls in RC in 2017

Operators at the Valencia Regional Emergency Communications Center (VRECC) respond to emergency calls from citizens in all five Valencia County municipalities as well from people in unincorporated Valencia Country.

Those operators dispatch law enforcement, emergency medical services, and fire equipment with firefighters from the \$3.2 million, 11,490 square foot VRECC building in Los Lunas behind the Village Administration Building.

Fireworks Ban, Restricted

The Rio Communities City Council has banned the sale and use of permissible aerial and ground fireworks through July 12.

In addition, the use of permissible fireworks is restricted through July 12.

In 2017 VRECC operators handled a total of 82,068 calls for all of Valencia County.

Calls in Rio Communities, estimated population of 5,558, totalled 3,636 with 2,655 for law enforcement; 850, medical; and 131, fire, in 2017.

Calls in Los Lunas, estimated population 15,338, totalled 24,498 with 20,828 law enforcement; 3,104 medical; and 566, fire.

Calls in Belen, estimated population 7,152, totalled 18,605 with 15,855 law enforcement; 2,362 medical; and 388, fire.

Calls in Bosque Farms, estimated population 3,803, totalled 4,809 with 4,271 law enforcement; 395 medical; and 143 fire.

Calls in Peralta, estimated population 3,585, totalled 4,686 with 3,971 law enforcement; 386 medical; and 329, Continued on page 2

fire.

The 850 medical calls in Rio Communities are 23% of the total calls made to the VRECC in Rio Communities.

For the other Valencia County municipalities, medical calls are these percentages:

Los Lunas 13% (3,104) of the 24,498 total Belen 13% (2,362) of the 18,605 total Bosque Farms 8% (395) of the 4,809 total Peralta 8% (386) of the 4,686 total

According to *Suburban Stats*, Rio Communities has 1,996 households with 1,038 households having one or more people over the age of 60 or 52%.

Los Lunas has 5,463 households with 1,746 households having one or more people over the age of 60 or 31%.

Belen has 2,887 households with 1,137 households having one or more people over the age of 60 or 39%.

Bosque Farms has 1,543 households with 694 house-

holds having one or more people over the age of 60 or 44%. Peralta has 1,370 households with 545 households having one or more people over the age of 60 or 40%.

Improving Life in the City

Project funding comes from sources that include legislative appropriations such as capital outlay, grants, the city budget, and loans.

New Street Signs and Lights

New street signs and lights will be going up in Rio Communities to help make the community safer and life easier for drivers.

Digital speed signs will be placed facing east on Hillandale, on Golf Course Road, west facing on Nancy Lopez, and east and west facing on Manzano Expressway near Highway 47.

Solar street lights will be placed at the intersection of Horner and Goodman, the intersections of Nancy Lopez and Highway 47, Frederico and Lee Trevino; and at the intersection of Guapo and Horner/Sunset.

Fire Rating of 4 / Fire Department

The Rio Grande Estates Fire Department continues to provide excellent service to the greater Rio Communities area. Because of that service, Rio Communities has a fire rating of 4 which impacts insurance costs. Lots of volunteers keep the fire department running. Support them whenever and wherever you can.

Business Licenses Available

Doing business in Rio Communities? Remember to get a business license from the City of Rio Communities. It's only \$35, available at City offices, 360 Rio Communities Blvd.

Use Rio Communities

The 87002 zip code now encompasses Rio Communities and Belen which is why it is important to use Rio Communities for all address issues.

When dealing with emergency services it is very important to tell the Valencia Regional Emergency Communications Center operator that the emergency is in Rio Communities when the emergency is in the City of Rio Communities.

Change any address information that says Belen to Rio Communities. Use Rio Communities as a return address. Change the addresses on your communication to Rio Communities rather than using Belen.

Economic Development Commission, Planning & Zoning Work to Better City

Economic Development Commissions and Planning and Zoning Commissions are often part of a municipality's day-to-day operation. This is true for many long-established communities.

Even though the City of Rio Communities is only five years old, an Economic Development Commission and a Planning and Zoning Commission meet regularly to help the municipality grow and flourish.

The Economic Development Commission has been looking at ways to bring more businesses to the city. One of the critical statistics for a business to locate in a municipality is the number of "roof tops" (homes) in that municipality, especially new roof tops.

The Planning and Zoning Commission is working with developers to bring new roof tops into Rio Communities. Those developers are looking at building new homes in Rio Communities which could help bring the new businesses citizens have been asking for.

The Economic Development Commission works with other economic development organizations in New Mexico, such as Albuquerque Economic Development and the state economic development office, to bring new businesses to Rio Communities.

Councilor Attends Finance Conference

City Councilor Arturo Sais joined the National Association of Latino Elected and Appointed Officials (NALEO) Educational Fund, the nation's preeminent Latino leadership organization, and nearly 50 other municipal and county level policy makers from across the country for the NALEO National Policy Institute on Public Finance and Pension Fund Management and Bonds held in May in Long Beach, CA.

Topics covered included The Role of Public Officials as Fiduciaries; Understanding the Budget and Revenue Sources; Financial Reporting and Forecasting; pension funds; and municipal bonds.

The conference goal was to enhances the knowledge of complex public finance issues. Attendees networked with officials from across the country.

Municipal Complex Improvements

Renovations of the City of Rio Communities Municipal Complex is being funded through Capital Outlay funds.

Capital outlay funds, in the context of government, are those used to build, improve, or equip physical property that will be used by the public. Roads, museums, playgrounds, schools, irrigation ditches, hospitals, lands, and furniture can all be capital outlay projects.

In New Mexico, state capital outlay is authorized by the Legislature and generally is nonrecurring – one-time – money.

Because of provisions in the New Mexico Constitution, capital outlay can only be used for government-owned facilities such as the municipal complex on Rio Communities Boulevard.

The City of Rio Communities received \$200,000 in capital outlay funds in 2014, 2015, 2016, and 2018 for a total of \$800,000 to make improvements on the municipal complex. These buildings were constructed in 1973.

The City Council has hired FBT Architects to coordinate the municipal complex renovations plus other improvements in the City of Rio Communities.
