### Navigating the City Website Is Easy

Searching for information about what's going on in the City of Rio Communities? The City has a great website filled with all sorts of information that might be just exactly what you are looking for.

For instance, you might be curious what goes on at City Council meetings. Go to the City home page by typing in the URL riocommunities.net. Once at the home page (pictured below), click on the icon on the right hand side of the page that has Agendas & Minutes below it. You will get a list of meetings of City bodies that includes agendas

and minutes.

You can click on the approved agenda before a meeting or click on the approved minutes following a specific meeting. You can also click on View Details and that will take you to that specific meeting page and both agenda and minutes will be available for viewing.

The City's accounts payable are now being published and can be found under the Agendas & Minutes under the date of the meeting after the accounts payable are approved.

If you are looking for customer complaint forms/solid waste collection

complaint forms/vacant property application/permits or any other forms, then click on the resources link at the top of the home page.

Click on Forms and Applications; you will find forms and applications used / required by the city.

Need help finding the Facebook links for the City?

On the upper right hand side of the home page is the Facebook symbol. Click on it and it will take you to the City's Facebook page.



#### Did You Respond to 2020 Census?

Work continues on the 2020 U.S. Census. If your household has not responded to the pleas to be counted there is still time to do so.

As of June 25, 2020, 68.8% of Rio Communities households responded online, by phone or by mail, to be counted in the 2020 Census. This compares to 74.5% in Bosque Farms and 51.1% in Belen.

In New Mexico there was a 50.7% self response rate as of June 25, 2020, while the national rate was 61.2%.

You can be counted for the 2020 Census by going to 2020census.gov or calling 844 330-2020 toll free. Make sure everyone in your household is counted to be sure Rio Communities is counted.

#### RC News Snippets

Burning is allowed in Rio Communities but only on days designated as "Burn Days." Check if it is a Burn Day on the Valencia County website, co.valencia.nm.us or call 505 866-2036. And be very careful as it has been very dry in New Mexico. Check the City website for fireworks limitations.

Remaining Saturday dates in 2020 when a dumpster will be at the City Hall, 360 Rio Communities Blvd., are July 18, August 15, September 19, October 17, and November 21.

The City Council has approved joining the Public Employees Retirement Association and approved health insurance benefits for employees, on an 80/20 percent split.

#### RC Public Works Department

The Rio Communities Public Works Department employees continue to work on various projects through out the municipality.

They have filled more than 70 potholes; picked up trash along the walking paths, fixed problems with the City Hall roof; made sure fire extinguishers work in City Hall; made sure City Hall has adequate COVID-19 safety markings; got the irrigation system up and running; and installed exterior cameras on City Hall among many other tasks performed.

#### UWSNM Now Collecting Trash

The roll out for Universal Waste System of NM (UWSNM) to collect trash in Rio Communities has done well considering it's been three months, points out Mayor Pro Tem Peggy Gutjahr.

The City Council approved a contract with UWSNM in February 2020 to collect all trash in the municipality.

A committee has been created to help deal with any problems with UWSNM's collection in Rio Communities.

Collection days are Mondays on the west side of Rio Communities Blvd. / State Hwy 47 and Tuesdays on the east side. All garbage should be bagged.

UWSNM is available by phone, 505 377-8833 (open 8 a.m. – 4:30 p.m.); online, uwsnm.com; or email, service@uwsnm.com. Offices are located on Broadway SW in Albuquerque, but an office in Rio Communities is expected to be open before the end of 2020.

#### P&Z, Building Permits

The Rio Communities Planning and Zoning Commission is working on an abatement ordinance and standard hearing procedures.

Building permits issued include one for a house on Frederico; two separate permits for houses on Nancy Lopez; multiple permits for solar roof top installations and two permits for storage buildings within the City.

This is the most permits issued in Rio Communities at one time in many years.

#### New RC Municipal Judge

Holly Noelle Chavez has been appointed Rio Communities Municipal Judge to take the place of Municipal Judge Heather Benavidez who resigned the position.

Benavidez was appointed to serve as a Valencia County magistrate judge following the retirement of Judge Tina Garcia.

Chavez's appointment as judge was approved by the Rio Communities City Council on a unanimous vote. She was sworn into office in May.

Court will now be held at 10 a.m. on the 2nd and 4th Fridays.

#### Animal Control, Law Enforcement

The City of Rio Communities Council and Valencia County Commission have approved two Agreements where Valencia County provides services to Rio Communities. They are:

- An ongoing agreement with Valencia County for continuing animal control services. According to the agreement, the city will pay the county \$30 per hour worked per animal control officer, and the county will provide housing, veterinary care, food and water for animals if they are seized in the City or surrendered by a resident. There is a charge of \$50 per day times 3 days per animal for housing paid by the City.
- An intergovernmental services agreement for law enforcement protection. The city will pay to the county \$150,000 annually for the services. The cost includes \$130,000 for the assigned deputy with things like a vehicle and equipment plus \$30,000 for coverage outside of the assigned deputy's duty time.

#### Library in Rio Communities Future

The Rio Communities City Council has unanimously approved a design for a public library. During the 2019 legislative session, \$50,000 was allocated for a public library in Rio Communities. The approved design is for a 1,000 square foot space where the old treasurer's office was located in City Hall.

Pecos Homes is building a model home in the Tierra del Sol golf community of Rio Communities. The model home will be open beginning Aug. 1, 2020, from noon to 6:00 p.m. Thursday through Sunday or by appointment.
