ICIP Can Improve Life in Rio Communities

The Infrastructure Capital Improvement Plan (ICIP) for Fiscal Years 2022-2026 for the City of Rio Communities includes parks, pavement reconstruction, public safety equipment, and upgrades to city hall.

The ICIP lists projects that improve life in the City if those projects are built. This list must be reviewed every year, so the City is ready if project funding becomes available.

The ICIP list is sent to the state legislature which can provide funding.

The first item on the city's list is public safety equipment with a cost of \$2,066,488 split over four years. This includes

various fire department equipment and design/construction of multiple helipad / heliport locations for emergency service transport.

The second priority is designing, renovating, furnishing, and equipping the city hall multipurpose complex for a total of \$1.7 million.

The third Rio Communities priority is \$1,125,000 for pavement reconstruction of roads and resurfacing collector roads. The fourth item on the list is \$640,000 for roadway beautification on a 1.6 mile stretch of road on NM Hwy 47 from NM Hwy 309 south to Nancy Lopez.

Number five on the ICIP list is \$860,000 for a parks and open space assessment plan for the City. Sixth on the list is \$1,050,00 for roadways, trails, paths, and sidewalks throughout the City.

Next is the purchase of 911 radio equipment for the Valencia Regional Emergency Communications Center. The \$6 million cost would be shared by the City of Rio Communities, Village of Los Lunas, City of Belen, Village of Bosque Farms, Town of Peralta and Valencia County.

Last on the list is \$1 million for a storm water and drainage infrastructure project.

Learn More About RGE Fire Department, Code Enforcement

The Rio Grande Estates Fire Department (RGEFD) is an integral part of the City of Rio Communities. Each issue of the Rio Communities News will carry a column about the Fire Department.

The RGE Fire Department has a new Volunteer Fire Chief. Andrew Tabet, the former Assistant Chief (EMT-Basic & Fire 1), was appointed head of the department June 11, 2020, by the Rio Communities City Council.

Marianne Rittner-Holmes, a retired Lieutenant/EMT-Intermediate, has returned as Captain to help the station administratively. Local volunteers are working hard to increase their skills and certifications to better serve the community.

RGEFD is hosting its second EMT-Basic class. The first class resulted in six people becoming licensed. This second class includes seven current members. Their completion date is December 2020.

Please wish them well in their studies!

RGEFD recently took possession of two brand new Brush Trucks used for wildland fires, which are common during the fire season. Thank you to our state lawmakers, State Fire Marshal's office, and City of Rio Communities councilors for the financial and moral support which made this possible.

Code Enforcer Gordon Reeves helps make the City of Rio Communities a safe place to live and work. The work of the Code Enforcer covers a wide variety of tasks in the community. Each issue of the Rio Communities News will carry a column about code enforcement

The first column talks about what is enforced.

Unlicensed Vehicles – Any motor vehicle that is required to be licensed which (1) does not have a license plate or (2) has an expired license plate, is considered an unlicensed vehicle. All such vehicles must have a valid license plate unless parked in a garage. Such vehicle left on the street or anywhere else than the owner's property will be tagged to be towed.

Inoperable Vehicles – Any motor vehicle that is not (1) capable of operating in accordance with State of New Mexico Law or (2) capable of moving under its own power is considered an inoperative vehicle. All such vehicles must be operable unless they are parked in a garage. Such vehicles left on the street or anywhere else than the owner's property will be tagged to be towed

Overgrown Lots – A lot or yard is considered overgrown when weeds or rank vegetation are allowed to grow to a height of 20 inches at this time, or briars and trailing vines exceed ten feet in length. This ordinance applies to any lot or parcel of land in a developed residential area or commercial area within the city limits of Rio Communities.

Extensions are granted on a case-by-case basis. Non-compliance results in a citation being issued, requiring a

The roll out for Universal Waste System of NM (UWSNM) to collect trash in Rio Communities continues to proceed smoothly, points out Mayor Pro Tem Peggy Gutjahr.

The City Council approved a contract with UWSNM in February 2020 to collect all trash in the municipality. UWSNM will have an office in Rio Communities starting this fall at 2308 NM Hwy 304.
