New City Manager Hits the Ground Running

In this visit with Dr. Martin Moore, the new City Manager, he discusses the move to Rio Communities and outlines an assertive agenda for his first 100 days in office, and beyond.

"I greatly appreciate the warm welcome to Rio Communities," says Dr. Moore. "The City Council, employees and citizens of our city have gone out of their way to make me feel welcome, and I look forward to my wife and family being here very soon."

Moving on to the topic of how he plans to approach his job, Dr. Moore shares that he is moving assertively to complete projects that were waiting for a City Manager to direct.

"We have hit the ground running on numerous items," says Dr. Moore. "These projects include, but are not limited to, completing the library space, filling key staff vacancies, preparing a balanced budget ahead of schedule, following through on street upgrade projects, scheduling the repair of potholes, replacing dead street lights, improving compliance enforcement, preparing strategic plans, completing grant projects, upgrading city ordinances, and respectfully responding to citizens' daily concerns."

When asked how Rio Communities expects to achieve such an assertive agenda, he replies that it is easily accomplished with "organized hard work, combined with a team effort involving everyone who works and volunteers at the city."

No 2021 Business License Fee

In an effort to help Rio Communities businesses recover from any effects from public health orders and other things during the COVID-19 pandemic, the Rio Communities City Council has voted to eliminate the 2021 business license fee that is charged every year.

Businesses must fill out the usual form and turn it into City Hall.

Be sure to support local businesses. Part of the Gross Receipts Tax you pay when shopping at businesses in Rio Communities goes to the City of Rio Communities in order to provide the needed services to the municipality.

Budget Procedures for Rio Communities

Budgets seem like mundane and dry topics, but budgets are important to New Mexico governments.

The City of Rio Communities has a process which must be followed each year to create the budget. Here is a simplified version to help better understand that process.

o Compile and average revenue predictions for next Fiscal Year 2022 Budget

o February 8 - Department heads meet on budget requests

o February 25 – March 1 budget requests from Department heads

o March 1 - Deadline for Department heads to submit budget requests

o March 8 – meetings with department heads *April*

o April 1 - Budget draft ready

o April 8 - Special budget workshop

o April 22 - Budget Hearing

o April 29 - Extra budget hearing (if needed) *May*

o May 11 - Council consideration of interim budget (tentative)

o May 20 - Interim budget submittal to NM De-

partment of Finance and Administration (tentative)

June

o June 1 Interim FY 2022 budget to DFA/LGD - deadline

July

o July 13th - BAR, Final Quarter and Budget Resolutions. Council consideration.

o July 15 - Final Quarter Reports and Final Budget submitted to DFA

o July 31 - Deadline to submit to DFA/LGD

o Final FY 2022 budget review and approval by DFA/LGD.

This is our on-going mission, and admittedly, though we may occasionally fail, we will nonetheless seek input from residents in this forum and in public Zoom meetings.
