A RESOLUTION OF THE MUNICIPALITY, RECOGNIZING THE COMMUNITY WELLNESS COUNCIL AS THE COUNTY WIDE HEALTH COUNCIL THAT CAN BE CONSULTED FOR GUIDANCE WHEN HEALTH OF VALENCIA COUNTY RESIDENTS MAY BE IMPACTED BY MUNICIPAL POLICY OR LAW.

WHEREAS, the Legislature of the State of New Mexico has provided for the creation of comprehensive community-based health services under the Maternal and Child Health Plan Act under the HB 721 Section 24- 1B; and the Community Wellness Council, 501c3, is contracted through the Department of Health to provide community health assessment and planning

NOW, THEREFORE, BE IT RESOLVED by this Governing Body of the City of Rio Communities, State of New Mexico, that at a duly convened regular meeting, approval was given to acknowledge the Community Wellness Council as a consulting resource, which will have the following duties:

- Provide non-binding recommendations to the Rio Communities City Council and the City of Rio Communities on health-related matters.
- Present community health data and/or issues at least once a year at a City Council meeting.
- The Community Wellness Council can present more frequently if requested by the City Council.
